**4 BUSINESS ARISING FROM PREVIOUS MINUTES**

**5 GENERAL BUSINESS**

**5.1 Race Day 14/03/10 – Round 10 Regatta 8 (20s – 500m) – Adelaide Phoenix**

The draft race day schedule and entries were reviewed.

**6 ANY OTHER BUSINESS**

- John Holland advised SARA had invited DBSA and Canoe SA to participate during their upcoming Masters titles being held on 1<sup>st</sup> May 2010 in mixed events to help reduce the lengthy delay between their races.

Clubs to consider whether they are interested in participating in any type of race format on this day and advise John Holland by Friday 12 March.

- Brief discussion held on frequency and cost of using the new race course. Noted the \$1500 cost went towards a depreciation fund to help maintain the course over a 20 year period and that it was owned by all three users (DBSA, Canoe SA and SARA).

Negotiations were being held to leave the course set up for the state championships and nationals events.

Clubs encouraged to use the race course at any time when it is not being used or booked for a particular event. Reminder to use the transit lane heading up to the Trimmer Parade end and to not stop in that lane.

- Clubs reminded of the requirement for drummer to hold the toggle also at the start line or may incur a time penalty.
- Noted that the floor on the yellow boat was very slippery.
- Alison Miller asked if DBSA was required to sight copy of the national police clearance certificate for their coach who is working with the juniors and advised yes and to keep original on their own file.
- Agreed meeting schedule to be set during the off-season on a monthly basis.
