• THAT the DBSA Constitution be amended as follows:

## 6.2 APPOINTMENT

- (ii) a) There must be no less than seven (7) and no more than nine (9)
  Committee Members which will comprise the Committee. The
  Committee shall be comprised of a President, Vice President Male,
  Vice President Female, Secretary, Treasurer, and two committee
  members.
  - b) The Committee may appoint up to two additional committee members. Each appointment would be for a two year term. Each appointee may only serve one term and would need to seek election in accordance with 6.1.

- At all times the composition of the Committee shall be a minimum of c) three (3) Females and three (3) Males.
- (iii) A Committee member shall be a natural person and be a Registered Participant or a Member of the Association.
- No more than two committee members at any time shall be members of any one (iv) member except by resolution of the Association in General Meeting.
- (v) A retiring Committee member shall be eligible to stand for re-election without nomination. No other person shall be eligible to stand for election unless a Member of the Association has nominated that person at least 28 days before the AGM by delivering the nomination of that person to the secretary of the Association. The nomination shall be signed by the proposer and by the nominee.
- (vi) The term of office for each Committee person shall be two (2) years.
- The committee members shall elect the President, Vice President Male, Vice (vii) President Female, Secretary and Treasurer from within the committee with a majority vote, with the President, Vice President Female, Treasurer elected in one year and the Vice President Male, Secretary and elected in the following year.
- (viii) All committee members shall upon the expiration of their respective terms of office be eligible for re-election for a maximum of two (2) additional consecutive terms.
- (ix) A person having completed 3 consecutive terms may renominate for the committee at the AGM following the AGM at which he/she stood down.
- Notice of all persons seeking election to the Committee shall be given to all (x) Members of the Association with the notice calling the Meeting at which the election is to take place.
- (xi) The Committee may appoint a person to fill a casual vacancy and such a Committee member shall hold office until the next AGM of the Association and shall be eligible for election to the Committee without nomination.
- The Committee shall be elected at the AGM. (xii)
- Balloting lists shall be prepared containing the names of candidates in alphabetical (xiii) order and each Member present at the AGM shall be entitled to vote in accordance with section 8.5(i), 5.1(i) & 5.1(iii).
